I am in good physical condition and am solely responsible for my personal health, safety, and personal property. I know that this Event is a potentially hazardous activity and I hereby voluntarily assume full and complete responsibility for, and the risk of, any injury or accident that may occur during my participation in this Event. I, for myself, my heirs, administrators, and executors (collectively, “Releasors”), hereby release and hold harmless and covenant not to file suit against. Notre Dame High School and their respective directors, officers, volunteers, agents, and employees; any event sponsor, the State of New York, the County of Chemung, the City of Elmira, the town of Southport, and their respective Legislators, officers, and employees, and all other persons or entities associated with the event (collectively, the “Releases “) for any injury or damages I might suffer in connection with my participation. I understand that this event takes place on public roads, not closed to traffic.
